Microplastics are silent pollutants present in the almost every corner of the planet, even the most isolated.





MICROPLASTICS

Tiny pieces of plastic material (<5 mm)

PRIMARY MICROPLASTICS

Directly released into the environment as small particles:

laundering of synthetic clothes
vehicle tyre abrasion during driving
personal care products e.g. facial scrubs

SECONDARY MICROPLASTICS

From breakdown of larger plastic items:

- plastic bags
- bottles
- •fishing nets, lures and lines

MICROPLASTICS

- A ban on intentionally added micro-plastics in cosmetics, personal care products, detergents and cleaning products by 2020.
 - A stricter norms for products such as textiles, tyres, paint and cigarette butts in order to reduce the release of micro-plastics from them.


SINGLE-USE PLASTICS

- A ban on certain single-use plastics such as cutlery, plates and balloon sticks
- Goods packaging companies have to contribute towards the cost of cleaning up discarded plastics.
- Restriction of lightweight plastics bags
